WALLEY ALSO SAID SHE HAD A GLASS OF WINE. I ASKED IF HE WAS WILLING TO DO FST'S SO I COULD FEEL CONFIDENT THAT HE WAS OK TO DRIVE.
BOLTON AGREED TO DO FST'S WHICH HE PASSED, I ASKED IF HE WAS WILLING TO TAKE A PBT WHICH HE SAID HE WAS. HE BLEW A 0.062 WHICH IS UNDER THE LEGAL LIMIT. SGT. TARLETON THEN ARRIVED AND WE SPOKE TO BOTH AS MY CONCERN WAS THAT BOLTON'S ALCOHOL LEVEL WAS LIKELY GOING UP BECAUSE HE SAID THEY HAD JUST LEFT APPLEBEES A SHORT TIME EARLIER. HE OFFERED TO HAVE A FRIEND RESPOND TO P/U BOTH OF THEM AND THE VEHICLE.
